SUB-FUND SCHEDULE

The date of this Sub-Fund Schedule is 16 April 2026.

The Company is authorised in Ireland by the Central Bank of Ireland (the “**Central Bank**”) as a designated investment company pursuant to Part 24 of the Act to market solely to Qualifying Investors and has been established as an umbrella fund with segregated liability between Sub-Funds. The Company is a QIAIF for the purposes of the AIF Rulebook. The Company has been structured as an umbrella fund in that the Directors may from time to time, with the prior approval of the Central Bank, issue different Series of Shares representing separate portfolios of assets which will comprise a Sub-Fund.
