I. Distribution in Portugal

Mercer Global Investments Europe Limited is a distributor of certain sub-funds of MGI Funds PLC in the national territory. Mercer Global Investments Europe Limited is authorised by the Central Bank of Ireland and registered under number 416688, being authorised to provide services and investment activities in financial instruments, namely receiving and transmitting orders on behalf of clients.

Dechert LLP is the Fund's paying agent in the national territory, namely for the purposes of physical and financial settlement of subscription and redemption orders for each sub-fund.

Mercer Global Investments Europe Limited will provide to the sub-fund investors, free of charge, on a durable medium, for consultation or copy, the mandatory documents under article 148 of the Portuguese Asset Management Regime, approved by Decree-Law no. 27/2023, of 28 April, namely the Fund's prospectus (including the sub-fund supplements), the latest published annual and semi-annual reports and the Key Information Document (KID) for each sub-fund, the latter in Portuguese.

Mercer Global Investments Europe Limited shall make disclosures of mandatory information, namely the net asset value of each sub-fund, at the abovementioned website.
