The Sub-Fund promotes social and/or environmental characteristics by predominantly investing in Primary Investments, Secondary Investments and Co-Investments with a view to mitigating environmental, social and governance risks.

The Sub-Fund intends to contribute to the limitation of adverse impacts on the climate and associated environmental challenges and/or to a more inclusive and equitable society and/or to improved living standards by focusing on Primary Investments, Secondary Investments and Co-Investments that are ESG risk aware and selected based on a rigorous investment due diligence process that is based on a dedicated exclusion screening for harmful activities and behaviours and complemented by a proprietary ESG analysis.

Given the nature of the strategy, focussed on real estate investments, the Sub-Fund may opportunistically support further evolving and relevant opportunities.

The Sub-Fund seeks to achieve a diversified portfolio of assets across different sub-sectors/strategies of the real estate universe.
